

### Directions:

I-495 (Long Island Expressway) to exit 44N, then take Route 135 North (Seaford Oyster Bay Expressway) for approximately 0.6 mile, then take Route 25 East (Jericho Tpke) for another 0.6 miles, turning left at the third light at South Woods Road, also called Joshua Vitale Way. (Woodbury Inn/Best Western and Stresa restaurant will be on the righthand side: name of street on right side is Piquets Lane/Joshua Vitale Way). Go approximately 1.2 miles, turn right into first entrance for Stillwell Woods Park. After entering parking lot, drive along the right side of the baseball and soccer field. The coursing site is just past the baseball/soccer fields.

**From North:** I-95 South to I-695 South (Throgs Neck Bridge). I-695 South becomes I-295 South. Take Cross Island Parkway South to exit 30. Take I-495 East (Long Island Expressway), then proceed as above.

**From South:** New Jersey Turnpike or Garden State Parkway to I-287 South (cross Outerbridge) to Route 440 North to I-278 East (cross Verrazano Bridge) to I-495 East (Long Island Expressway), then proceed as above.

**From West:** I-80 East (cross George Washington Bridge) to I-95 (Cross Bronx Expressway) to I-295 (cross Throgs Neck Bridge), then follow instructions from North.


- ✓ All entries must be one year of age or over on the day of the trial.

- ✓ Hounds not present at roll call will be scratched.
- ✓ A fee of \$20 will be assessed for any returned checks.
- ✓ There will be a \$5 fine for any loose hound on the field that is not part of the course in progress.
- ✓ Battery-powered, continuous-loop lure machine will be used.
- ✓ The lure will consist of plastic bags and/or fur strips.
- ✓ Persons exhibiting conduct detrimental to AKC/BASHA/any hound(s)/other person(s) will be asked to leave the trial site.


### Saturday course plan
