I have received your last letter together with the \$2.00 asking for some information regarding the Cooley's that once lived in this (ADAIR COUNTY) and I have made a record search over at the Clerk's office and find the following information.

Marriage License from Wm Cooley To Patsy Reed, in Marriage Bond Book P.481.

Marriage License from Wm J. Cooley to Elisabeth Bryant." " " 1748.
his age at that time, was 23~~ys~~rs. (Cet, No)

wrote about this June 9-1832

Daniel Cooley, &c To Thomas January, in Book C. page 414. conveyance.

~~XXXXXXXXXX~~ Aaron Cooley's appraisment list in 1845, by James Humphrey's & Et-al as Administrator's. in Will Book E. page 14 to 15. although I fail to find any Will on record from this Mr Cooley. SURELY THERE MUST BE ONE.

I also findd that Aaron Cooley paid the price of \$2.50 for 50 acres of land VACANT LANDS. in ADAIR COUNTY KY. to Mr Clayton Miller, who was then Treasur of Adair County. this was by an act of the Legislature approved Feby, 21st. 1837. in Land Warrant Book No, 4 page 85.

I also find that John Cooley was appointed Constable in 1819. with James

Humphress as security.in BOOK D.PAGEv&(79) .

I also find that Aaron Cooley was released*an error in his tax receipt of \$4.00 in 1827. in Oct.in Book E page 134.he also presented his acct for \$25.93 in 1830,in Book P.272.

was also appointed Capt Military in 1830.Book P.page 277.

I also find in Minute Book G.page 243,that Aaron Cooley's appraisment list was filed,but I can not locate the Will of this Aaron Cooley.

I find an administrator appointed for Aaron Cooley in Minute Book G page 237

I am thinking that the County Court Clerk's office of ADAIR COUNTY,will unfold more information about the Cooley's,and as I have been absent from the Clerk's office for more than two years,in which the Books and records of Wills Deeds,&ect,have most all been changed and replaced in diffrent sections,that I should advise you to write to Mr W.E.Harris,the Present County/ Court Clerk and ask him to try to obtain some of the information that I have failed to get for you.most ESSPECIALLY,furnish you with the Will of one Aaron Cooley,deceased,and that WILL would likely show some of the names of the Cooley's.

I am also writing to the County Court Clerk of Madison County Kentucky,to see if I can get you some of the information,that you are in search of.

I am also writing to a friend of mine in Frankfort Kentucky.to see if he can locate a LAND WARRANT,or PATENT,in the Name of Aaron Cooley.

when I get the information I will immediately write you the findings.
